The PayPal price for UK subscriptions has been increased to £27 as there are fees which reduce the amount that the NUTS actually receive. We are also approaching the limit of PayPal income where things get complicated with PayPal, so we would prefer UK subscribers to pay by cheque if at all possible. Note that if you join during the year, you will be sent the issues of Track Stats that have been printed up to that point, plus the other issues when they are printed.

Under the General Data Protection Regulation (GDPR), the NUTS has obligations regarding your personal data.

The personal data that you provide us with in order to be a member of the National Union of Track Statisticians may be used by members of the Executive Committee which is appointed at each year's AGM.

We only need your name, postal address and e-mail address (if you have one). In the past the NUTS has collected dates of birth and telephone numbers. These are not essential to our work, although they are useful in some respects. Therefore those are now optional items on the renewal form and the NUTS will only retain this data if you provide it again this year. Note that years of birth are in the public domain for everyone born in the UK before 2006, so we may still choose to retain that information.

The legal basis for the NUTS to process your data is to fulfil our obligations to you as a member. This falls under the "contract" lawful basis, rather than needing any extra consent other than for storing your date of birth and phone number.

Your address data will be shared with the companies that print our publications, as they post these directly to our members. Those companies are currently the Ludo Press for Track Stats and Lulu.com for print-on-demand books, including the NUTS Annual. Those companies are also subject to the GDPR and have an obligation to protect your personal data.

Your postal address and e-mail address will be used for: 1) sending you publications as part of your membership; 2) keeping you informed of NUTS publications and events, for example the AGM; 3) asking whether you can help with the objectives of the NUTS.

Your data will be kept by the NUTS whilst you are a member, and for a period after your membership lapses, in order to remind those people who might have forgotten to renew their membership.

Your rights under the GDPR are unaffected by this privacy statement. Any enquiries about your data should in the first instance be directed to the Secretary of the NUTS, who acts as Data Protection Officer – secretary@nuts.org.uk.
